

How Texas's Statute of Limitations Impacts Personal Injury Cases

When someone is hurt in an accident, the last thing on their mind is a legal deadline. Yet in Texas, the law places strict time limits on how long an injured person has to bring a lawsuit. These deadlines, known as the statute of limitations, determine whether victims can recover the compensation they need for medical bills, lost income, and other damages. Missing the filing date almost always means the case is barred, no matter how severe the injuries or how obvious the fault.

Understanding the Texas statute of limitations is one of the most important steps accident victims in Houston can take after a serious crash, slip and fall, or workplace injury. The rules are complex, the exceptions are narrow, and insurance companies are well aware of how the clock can be used against victims. What is the statute of limitations in Texas personal injury cases?

In Texas, most personal injury claims, whether from a car accident on I-45, a truck crash on Beltway 8, or a slip and fall at a Houston business, must be filed within two years of the date of the accident.

This two-year limit applies to:

- [Car, truck](#), and [motorcycle](#) accidents
- [Pedestrian](#) and [bicycle](#) accidents
- Slip and fall or [premises liability](#) claims
- [Wrongful death](#) cases
- Industrial and [workplace injury](#) lawsuits

Importantly, the statute applies to lawsuits. While an insurance claim may begin right after an accident, if negotiations stall and the deadline passes without a lawsuit being filed, the right to compensation is lost forever. For accident victims in Houston, this makes acting within the two-year timeframe absolutely critical.

Why the statute exists and why it hurts victims

The law is designed to keep claims timely. Courts want to ensure that evidence is fresh, witnesses remember what they saw, and defendants are not surprised by lawsuits years later. While this may make sense in theory, in practice, it often works against victims.

Insurance companies know how quickly two years can pass. Adjusters may delay negotiations, ask for endless documentation, or make repeated requests for medical updates, all while the statute of limitations clock ticks down.

Meanwhile, victims are focused on healing, working through medical treatment, and trying to stabilize their lives. The result is that by the time many realize the insurance company doesn't want to pay fair compensation, the deadline may be dangerously close.

Exceptions that can extend or pause the deadline

Although Texas law is strict, there are limited exceptions where the statute of limitations may be extended or paused. Understanding these exceptions is critical, because assuming one applies without legal confirmation could end up destroying a case.

Some of the most common exceptions include:

- **The discovery rule:** Sometimes, injuries are not immediately known. A traumatic brain injury, internal bleeding, or toxic exposure may not show up until weeks or months after the accident. In such cases, the statute may begin when the injury is discovered – or should have been discovered – rather than the date of the accident.
- **Minors injured in accidents:** When a child is hurt, the statute does not begin until the child turns 18. This allows minors time to pursue their own claims as adults.
- **Wrongful death:** In wrongful death cases, the statute typically begins on the date of death, not the date of the injury that caused it.
- **Defendant absence or concealment:** If the at-fault party leaves Texas or actively hides their identity to avoid responsibility, the statute may be tolled (paused) until they are located.

These exceptions are narrow and frequently challenged by defense attorneys and insurers. Relying on an exception without confirmation from a knowledgeable Houston personal injury lawyer is risky and could close the door on recovery before the victim realizes it.

Why delay can harm a case

Even with two years on the clock, waiting too long to pursue a claim can have devastating consequences. The strength of a personal injury lawsuit depends on evidence, and evidence has a short shelf life.

Key risks of delaying include:

- **Disappearing evidence:** Skid marks on Houston roads fade, damaged vehicles get repaired or scrapped, and businesses overwrite surveillance footage.

- **Unreliable witness testimony:** Memories fade quickly, and witnesses may move away or become impossible to locate.
- **Weakened medical records:** Gaps in treatment or delays in diagnosis make it easier for insurers to argue the injuries are unrelated.
- **Insurance company tactics:** Adjusters often drag their feet, hoping victims will run out of time to file.
- **Reduced leverage:** Once the statute expires, there's no legal recourse, and insurers know they can walk away without paying.

Acting promptly helps preserve evidence, strengthen the case, and maintain maximum leverage for a full financial recovery. Waiting only benefits the insurance company, not the injured victim.
